RESOLUTION NUMBER 1163

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF PARADISE VALLEY, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD FOR TOWN COUNCIL ON MARCH 11, 2008

WHEREAS, the Town of Paradise Valley, Maricopa County, Arizona, held a Primary Election on the 11th day of March, 2008 for the non-partisan at-large election of four Council Members; and

WHEREAS, in accordance with Resolution Number 1060 the election was conducted by “all-mail ballot”; and

WHEREAS, the election returns have been presented to, and have been canvassed by, the Town Council of the Town of Paradise Valley.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Town Council of the Town of Paradise Valley, Maricopa County, Arizona, as follows:

SECTION 1. That the total number of valid ballots cast at said primary election, as shown by the poll lists was 3,132.

SECTION 2. That a total of 68 ballots were rejected.

SECTION 3. That the total votes cast for each candidate for Town Council were as follows:



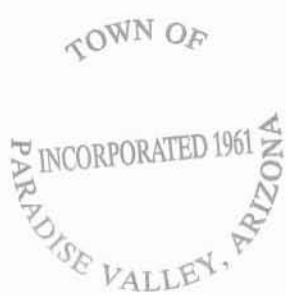
